

## Gold Edges Higher on Late Week Recovery as Unemployment Numbers Miss

### Precious Metals

Another tough week for gold, however a recovery late in the week resulted in a slight positive move week-over-week with gold up +0.8%, closing at US\$1,756/oz. The USD rallied most of the week, and conversely gold tumbled, on the Federal Reserve narrative of an end to asset purchase and interest rate hike by late next year. However, Thursday's weaker than expected unemployment numbers put that narrative into question – applications for US state unemployment benefits unexpectedly rose for a third straight week, and the US dollar pulled back providing gold with some breathing room.

Also, on Thursday, Federal Reserve Chairman Jerome Powell testified before the House Committee on Financial Services. In what was interpreted as dovish commentary, Powell stated that the US is "far from full employment" which the market interpreted as a sign that the US central bank could delay reducing stimulus. Fed tapering is expected begin in November, however the Fed likely wants a strong job market before it announces the commencement of the program. Despite gold's modest weekly gain (+0.8%), the mining indices underperformed bullion, with the VanEck GDX index finishing the week down ~1.4% and the junior GDXJ index finishing down ~2.1%, however, faring better than the broader S&P500 index, which finished the week down ~3.2%.

### Base Metals

Base metals finish the week down. The copper price pulled back by 3.7% WoW to \$4.06/lb, as the economy was impacted by power constraints and ongoing credit concerns stemming from Evergrande. China's manufacturing purchasing managers' index (PMI) contracted to 49.6 in September, from 50.1 in August, or its lowest level since February of last year. On the other hand, the Caixin China General Manufacturing Purchasing Managers' Index (PMI), which provides a more independent reading of China's manufacturing sector, rose to 50 in September from 49.2 in August. These conditions of slowing economic growth have impacted the demand for industrial metals, however, metal supply remains tight, as Shanghai copper inventories declined to 12-year lows, while LME stockpiles have declined 12.6% MoM. Nickel was down 7.4% WoW at \$8.14/lb, as energy control measures affected China's consumption of stainless steel. As a result, many Chinese steel mills have opted to place facilities on care and maintenance. Stainless steel production comprises 66% of global nickel demand and decreasing consumption continues to impact prices. Zinc prices also declined, down 3.6% WoW at \$1.35/lb, despite declining LME zinc inventories, down 10.3% MoM. In Europe, rising energy prices are impacting zinc smelters, which have been forced to reduce output during peak power periods.

Despite metal prices declining during the week, base metals equities finished the week mixed as reflected by the Global X Copper Miners ETF that was down 2.0% WoW, and the S&P/TSX Global Base Metals Index that remained relative unchanged, down 0.3% WoW. Among North American base metals producers, Hudbay Minerals was up (6.3%), Taseko Mines was up (5.8%), Copper Mountain Mining was down (6.3%), and Nevada Copper was down (15.3%).

### Weekly 'Nuggets'

Sector news this week was notable, highlighted by Tuesday's announcement of a proposed mega-merger between senior Canadian gold miners Agnico Eagle Mines (AEM-T, Not Rated) and Kirkland Lake Gold (KL-T, Not Rated). There had been rising speculation over the past several weeks surrounding a potential M&A deal involving Kirkland, with shares rising over several trading sessions prior to the announcement. The proposed all-stock deal, valued at ~US\$11 billion, would create one of the world's largest gold producers, with an implied pro-forma market cap of C\$24 billion, smaller than only Newmont (NEM-T, Not Rated) and Barrick (ABX-T, Not Rated). The new Agnico Eagle would hold assets located across four countries (Canada, Australia, Finland, and Mexico), including a portfolio of 12 operating mines with an expected output of 3.4 million ounces of gold this year (75% in Canada), and ~3.6 million ounces by 2023, and 48 million ounces of gold booked in reserves (85% in Canada). The proposed terms outline 0.7935 of an Agnico share per Kirkland share, representing a nominal 1% premium to Kirkland's 10-day VWAP average as of last Friday, with Agnico shareholders owning ~54% of the combined company, and Kirkland shareholders owning the remaining ~46%. The new Agnico Eagle will be led by a combined board and management team including seven directors from Agnico and six from Kirkland, with Agnico Eagle CEO Sean Boyd assigned to executive chair of the board, and Kirkland Lake Gold CEO Tony Makuch appointed to chief executive officer of the combined entity. The deal is expected to close in either December, or early next year, following a shareholder vote (66 2/3% of votes by KL shareholders required) scheduled to take place later this quarter.

### Chart of the Week – "Made in Canada – Key Domestic Projects Ripe for M&A Consideration"


In light of this week's proposed merger announcement between Canadian miner's Agnico Eagle and Kirkland Lake Gold, we have taken an opportunity to outline a list of key projects located in Canada which may represent attractive targets as M&A activity, particularly in the Canadian gold space, leads the way across the broader gold mining sector. We anticipate that further sector consolidation through M&A activity will be at the forefront given; **1)** the sector's capital allocation strategy as cash-rich producers seek to maintain existing production profiles and consider longer-term growth opportunities, and **2)** the attractive asset valuations across the junior space (GDXJ down ~29% YTD vs GDX down ~18%).

Our compiled list (on the following page) of 25 Canadian assets was selected using the following additional criteria: **1)** > US\$50 million operator market cap, **2)** > 2 Moz Au total resource (M+I+I), and **3)** > 0.50 g/t Au average resource grade. In addition to outlining the data for these metrics, we have outlined two other key metrics; **1)** project NPV/CAPEX ratio (using base-case assumptions from most recent technical report if available), and **2)** the Enterprise Value per ounce (EV/oz Au) for each respective project and operator. Of note, our dataset highlighted an average (excl H/L) resource of 5.4 Moz Au at an average grade of 1.94 g/t Au, with an average NPV/CAPEX ratio of 1.6x and EV/oz of US\$62/oz Au.

Select operators and associated projects which screened notably against the aforementioned metrics include; Sabina Gold's (SBB-T, Not Rated) Back River project in Nunavut (EV/oz of US\$40 and cons. P/NAV of 0.40x), Osisko Mining's (OSK-T, Buy, \$7.75 target) Windfall Lake project in Quebec (EV/oz of US\$88 and cons. P/NAV of 0.38x), and Artemis Gold's (ARTG-V, Buy, \$10.00 target) Blackwater project in British Columbia (EV/oz US\$40 and cons. P/NAV of 0.43x).

##### The Truth Machine Unveils Shallow and Higher than Expected Grades at Kwanika: Grade and Expansion Upside Potential in Resource Update

- ◆ **Our Take:** Positive on Grade and Potential to Expand Near-Surface Footprint: Yesterday's results represent the second batch of assays from drilling at Kwanika this year, with drilling continuing to show an expanding mineralized footprint at Kwanika. The release highlighted shallow high-grade mineralization across several intersections, and encouragingly, returned higher than expected grades in areas that had been previously modelled to show no grade or lower grades. Encouragingly, several holes from the release demonstrated appreciable grades (highlight hole K21-212: returning 45.8m at 1.57% CuEq), in many instances exceeding our average modelled resource grade for Kwanika. As such, we believe yesterday's results, and continued delivery of high-grade sections could be augmentative to the overall resource grade (see Figures in report for results vs block model).

#### Pegasus Taking Flight as Anglo Stays the Course; Scoping for a 2022 Drill Campaign Now Underway

- ◆ **Our Take:** Premier Partner Backstops Value at Drill Ready Targets: As per the earn-in agreement, this morning's payment combined with the US\$12.9 million of cumulative spending as of June 30th, 2021 provides Anglo with a 25% ownership stake in the Pegasus A and B projects, with Anglo eligible to earn-in up to 60% following a cumulative US\$57.3 million commitment by 2024 (up to 70% if final project construction is financed by Anglo). In our view, Anglo continuing to stay the course on the staged cash payments represents a positive read through on the potential at Pegasus. Several drill ready targets have been outlined through early geophysics work, with Anglo having commenced field and community engagement at Pegasus A earlier this month, ahead of an ultimate drill campaign guided to commence in H2/22.
- ◆ Overall, we are encouraged by today's announcement, which in our view adds to the discovery and growth potential of Luminex's assets in Ecuador with work being undertaken concurrently on several projects. Future work is expected to add to the overall value of the Company's early-stage gold- and copper-rich portfolio. We look forward to ongoing results from Cascas, Tarqui and Nayumbi, while ongoing project optimization studies continue at Condor North with drilling around the Camp Zone NW extension expected soon.


### Mayfair Gold Corp. (MFG-V, \$0.64) | No Rating | No Target

#### Fenn-Gibb Expansion Zone Drilling Rolls: We See Potential for Pit Expansion as More Drilling Due Ahead of Year-End Resource Estimate

- ◆ **Our Take:** Mayfair announced another batch of assays from its ongoing 50,000 metre Phase 1 drill program at the Fenn-Gibb project in Timmins, Ontario. Currently, infill and resource expansion drilling at Fenn-Gibb is supported by four rigs (up to six rigs expected) with 38,000 metres across 55 holes completed, and additional results still pending. **The most recent release outlined assays from five holes collared at the Fenn-Gibb Expansion Zone, below the central section of the pit-defined resource, which show potential for incremental pit expansion with further drilling to depth warranted to examine continuity of high-grade zones.**
- ◆ Overall, the recent results continue to support the tabling of a larger resource base (current resource: indicated @ 2.08 Moz grading 0.921 g/t Au and inferred @ 75 koz Au grading 0.618 g/t Au) at the Fenn-Gibb property, with several high-grade sections (> prevailing resource grade of 0.92 g/t Au) encountered from deeper expansion drilling below the prevailing pit-shell. The Company has allocated two of the four operating rigs to target the Expansion Zone in efforts to delineate additional, higher-grade gold mineralization ahead of an updated resource estimate.



Precious Metals Weekly Change (12 weeks)













## Base Metals Prices & Inventories Charts














Weekly Performance – Precious Metals Companies (Small Cap)


## Equity Weekly Performance – Base Metals Companies
